This Privacy Policy, to be read in conjunction with the primary <u>Privacy Policy</u> outlined on our website, outlines how we collect, use, and safeguard your personal information. By submitting your work to us, or requesting services from us, you agree to the terms of this policy.

Information Collection

We may collect the following additional personal information from authors during the submission and editorial process or during the request for services:

- Name, contact information, and professional details (e.g., email address, phone number, mailing address, biography).
- Manuscript or work submitted for consideration for publishing or for the provision of services.
- Payment details (e.g., bank account details, PayPal account details, credit card) if the author is offered a contract for publication of the manuscript or work submitted.
- Name, contact information, and professional details of the author's agent.

- Name, contact information, and professional details of the author's lawyer.
- Any additional information voluntarily provided by the author.

Use of Information

We use the information collected for the following purposes:

- To evaluate and review the work submitted for potential publication.
- To communicate with authors regarding the submission process, updates, and feedback.
- To maintain records of works submitted and details of the author.
- To provide services to the author.
- To comply with legal obligations and protect Our rights.

Information Sharing

As an author submitting to Us as a publisher, or as a service provider, access to your personal details will be limited to authorised individuals who have a legitimate need to access that information.

We may share your personal information with the following parties, strictly on a need-to-know basis:

- **Editorial Team:** Our editorial team, including editors and reviewers, may have access to your personal details for the purpose of evaluating and reviewing your submitted work.
- Administrative Staff: Our administrative staff, such as submission coordinators or administrative assistants, may have access to your personal details to facilitate the submission process and handle administrative tasks.
- Legal and Compliance Team: In certain circumstances, our legal and compliance personnel may have access to your personal details to ensure compliance with applicable laws and regulations. (e.g., for contract terms and conditions).
- Legal and regulatory authorities: if required by law or to protect our rights.
